PLANNED GIVING TOOLS

The following Planned Giving tools can be used to support FBH International. Each offers means of **reducing your personal and estate taxes while increasing your retirement income and your ability to give** to a greater extent than you may have imagined. With Planned Giving, you can see the fruit of your years of work now as you give to the Lord's work. Here are two that you might not be aware of:

Donor Advised Fund (DAF)

This tool allows donors to make charitable contributions, receive immediate tax benefits and then recommend the distribution of funds over time to any local church or ministry with charitable status.

A donor can add to the fund as often as they would like and then advise any amount of funds to be distributed when they are ready.

Charitable Gift Annuity

This tool is a way to make a gift to support the Lord's work that will provide you with a guaranteed source of fixed income for life, most or all of which will be tax exempt. The annuity requires no management and the initial capital amount will produce an immediate one time tax receipt for at least 20%.
